**Payment Policy:** Payment is due in full prior to transfer of remains and before services are rendered. We accept American Express, Discover, Master Card, Visa.

### **BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF AND OVERHEAD .....\$725.00**

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. **(This fee is already included in our packages.)**

### **EMBALMING.....N/A**
